



## APPLICATION FOR LOW-INCOME HOUSING

### ADMISSIBILITY

According to the regulations for low-income housing attribution of the Société d'habitation du Québec, the **annual income of your household must be less** than the following maximum:

#### **To be eligible for low-income housing, the applicant must:**

1. Be registered on the waiting list.
2. Provide independently or with the help of outside support or from a person who lives with him, the satisfaction of basic needs, particularly those related to personal care and ordinary household tasks.
3. Be a Canadian citizen or permanent resident as defined in the Immigration Act (L.C. 2001, c. 27), and **be a resident of Quebec**.
4. For at least 12 months during the 24 months preceding his application or reinstatement, reside in Quebec or if the rules of the landlord provides, in the territory of selection of the landlord. This section of the regulations does not apply to the applicant (or a member of his household) who is suffering from locomotor disability (wheelchair) or is a victim of domestic violence.
5. Have an annual income below the maximum gross.

#### **The applicant, or any member of his household, must not:**

1. Have a debt to a landlord of low-income housing.
2. Have liquid assets or property which exceeds the maximum amount prescribed by regulation of the landlord (100 000.00 \$).
3. Be a full time student enrolled in an educational institution, with no dependent children in his care.

#### **For your information:**

## CHECKLIST

Please join the following documents to your application:

### MANDATORY TO ALL:

- 1. The **signed** application for low-income housing
- 2. **Sheet with choice of sectors signed**
- 3. For the applicant: **proof of citizenship or permanent residence** (for example: birth certificate, passport, certificate or citizenship card, permanent residence card, imm2000 forms, etc.)

For the other adults: an **identity document** (for example: health insurance card, driver's license, passport, birth certificate, etc.)

For children: **long-form birth certificate** showing parents' names (immigration documents that identify who they arrived in the country with may be considered)

- 4. **Provincial notice of assessments** (Revenu Québec) for all members of your family aged 18 and over (except for children attending school full-time, with supporting documentation)
- 5. **Proof of address, of your current residence, received within the last two months, that includes your name and address** (for example: recent bill or letter confirming your address, etc.)
- 6. **Proof that you have lived in Gatineau or Québec for at least 1 year during the 2 years preceding your application** (for example: lease, bills, driver's licence, or any documents confirming your address during this period, etc.)
- 7. Proof of the **value of your belongings** and those of your family members, **excluding furniture** (for example: property, land, investments, etc.). Your assets must be less than \$100,000.

### IMPORTANT INFORMATION:

- **NEW:** Your application remains valid for a **period of 2 years** with a possibility of renewal. **However, if you situation changes** (annual income, new address, your health status, pregnancy, addition of occupant, liquid assets or property, etc.) you have the **responsibility** to provide us with documents to that effect. **Failing to notify us of any changes in writing, a housing offer could be withdrawn.**
- The Office d'habitation de l'Outaouais has **30 working days** to inform you of its decision on your application and registration to the waiting list. If there is a refusal, you will be given the reasons. You can then contact the Tribunal administratif du logement for a review.
- The **refusal** of a housing offer that is in the sector corresponding to the choices made will result in the **removal** of the application for a **one year period**. After the one year period, the applicant must reapply. Removals result in the **loss of seniority** of the applicant.
- By subscribing to the Office d'habitation de l'Outaouais, you agree to have your name used for subsidized housing whose selection is managed by the Office d'habitation de l'Outaouais, that is to say, with other owners.
